#### **CIRCULAR**

**Subject:** Engagement of retired Government Servants as Consultants in the Central Administrative Tribunal on contract basis.

Applications are invited in prescribed format (as per Annexure-I) to engage eligible retired Government officers/officials as Consultants in the Central Administrative Tribunal on short term contract basis initially for a period of one year which may be extended or curtailed in administrative exigencies from time to time. Details of posts along with the remuneration, tentative location of posting and eligibility criteria for engagement on contract basis are as under:

- 2. Age Limit: The maximum age limit for appointment on contract basis shall not exceed 66 Years as on the closing date for receipt of applications.
- 3. Remuneration: The remuneration to be paid to the Consultants hired on contract basis will be regulated in terms of Department of Expenditure OM No. 3-25/2020-E.IIIA dated 09.12.2020 as under:
  - (i) Basic Pay at the time of retirement minus Basic Pension. The amount of remuneration so fixed shall remain unchanged for the term of contract. There will no annual increment/percentage increase during the contract period.
  - (ii) An appropriate and fixed amount as Transport Allowance for the purpose of commuting between the residence and place of work shall be allowed not exceeding the rate applicable to the appointee at the time of retirement. The amount so fixed shall remain unchanged during the term of appointment. However, retired employees engaged as consultants may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.
  - (ii) No other allowances shall be admissible.
- 4. Leave: Consultants hired on contract basis will be eligible for 1.5 days leave for each completed month of service which may not be accumulated beyond a Calendar Year/Contract period.

#### 5. General Conditions:

- The Consultants shall perform the duties as assigned by the Head of Office/Head of Department.
- (ii) This Office reserves the right to accept or reject in part or in full any or all the responses without assigning any reasons whatsoever.
- (iii) The decision of the Competent authority on selection of the candidates will be final and no correspondences on this subject will be entertained.
- (iv) This Office will not be in a position to return any of the documents provided by the applicant / parent office of the applicant, irrespective of his / her selection.
- (v) Applications received after the expiry of last date or found incomplete or not accompanied with required documents or incomplete applications, will not be entertained.
- (vi) The engagement will be purely on contract basis and shall not bestow any right for regular or permanent employment or for continued contractual appointment.
- (vii) The appointee will have to comply with the requirements of the CCS (Conduct) Rules, 1964 and all Rules and Orders already in existence regarding attendance, duties, discipline, conditions of service etc. will have to be followed.
- (viii) The appointee shall not be entitled to any benefit of Provident Fund, Pension, Gratuity, Medical expenditure re-imbursement, Government residential accommodation LTC, TA or any other benefits / concessions admissible to Government servants.
- (ix) Department shall reserve the right to terminate his/her engagement at any time either without giving any notice or giving a notice period of one month. He / She can resign after giving one month notice in advance.
- (x) The retired Govt. servants that are already engaged in different Benches of CAT may also apply against this Vacancy Circular for different posts as mentioned above.

  - (c) Copy of PPO.
  - (d) Copy of Last Pay Slip.
  - (e) Any other documents/certificates mentioned in Annexure I.
- v. Last date for receipt of applications will be within 01 month from publication of this Vacancy circular in the Employment News.
- vi. The Govt. Officers retiring who are going to retire shortly on attaining the age of superannuation are also eligible.
